

HEALTH STATUS QUESTIONNAIRE (Coronavirus COVID-19)

Health, safety and ensuring a pleasant journey for all passengers and crew are of utmost importance to Boat Bike Tours.

As part of government measures to prevent the spread of the Coronavirus COVID-19, Boat Bike Tours – as organizing and executing tour operator – is required to ask all guests some questions about their state of health at the start of their tour.

For this reason, we ask you to please answer the following four questions in advance, but no more than 12 hours before boarding. We also ask you to provide some personal details. Upon your arrival on board (check-in), this form will be collected by a crew member and kept in a safe place.

Completion of this form is mandatory for all guests.

If you are unable to answer "NO" to all four questions, an additional interview or check may be required before you can be admitted on board and participate in the voyage.
